## ANNUAL SUBSCRIPTION RATES/ MEMBERSHIP TYPE REQUIRED (tick as appropriate)

Full Membership £45

LIFE MEMBERS and FULL MEMBERS receive all the benefits and privileges of Membership including eligibility to receive Championship Points and S.S.A. rosettes in Equitation Qualifying Classes.

Junior Membership £30

A JUNIOR MEMBER is a Member aged under eighteen on 1<sup>st</sup> January of the current year. A Junior Member must have attained their 5<sup>th</sup> birthday by 1<sup>st</sup> January of the current year in order to compete in S.S.A. affiliated classes to be able to receive Championship Points and S.S.A. rosettes in Equitation Qualifying Classes. A Junior Member may not vote at General Meetings.

Associate Membership £25

AN ASSOCIATE MEMBER receives the same benefits as a Full member but may not receive Championship Points or S.S.A. rosettes in Equitation Qualifying Classes.

Overseas Full Membership £45 (€69)

Overseas Junior Membership £25(€30)

Overseas Associate Membership £30 (€45)

Life Membership (Adults) Overseas & UK £500.00

Subscriptions are due on 1<sup>st</sup> January annually or on joining.

A registration fee of £5.00 is payable on joining, or on renewing after 31<sup>st</sup> March. If the direct debit form is not completed, a cheque administration fee of £4 is payable.

All Membership applications not made online **must** be accompanied by a cheque or postal order for the current year. If the direct debit form is completed, the £4 cheque administration fee will be waived and the direct debit automatically collected the following year. The subscription for the following years will be debited each January thereafter as long as the direct debit instruction remains in force.

**A new direct debit without a cheque will not be accepted.**

Alternatively you can choose to renew online.

New members joining after 1<sup>st</sup> October will not be required to renew their membership until 31<sup>st</sup> December of the following year.
